The training course will be organised by the Institute for Cooperative Studies, Humboldt University Berlin, Germany, and the Institute of Agricultural Economics, Sofia, Bulgaria, It is the first training course in the series of events offered by the Marie Curie Project on "Modern Agriculture in Central and Eastern Europe: Tools for the Analysis and Management of Rural Change" (MACE). Objectives of the Marie Curie Project

The MACE Project seeks to enhance the capacity for agricultural research in the scientific community of the CEECs and thus to contribute to managing the process of agricultural modernisation in these transition countries. It is coordinated by Humboldt University Berlin, Germany, and jointly conducted with the following partners: Leibniz Institute of Agricultural Development in Central and Eastern Europe Halle, Germany, Research Institute of Agricultural Economics Prague, Czech Republic, Warsaw University, Poland, Corvinus University Budapest, Hungary, Slovak University of Agriculture Nitra, Slovakia, Brandenburg University of Technology Cottbus, Germany, Leibniz Institute of Agricultural Engineering Bornim. Germany, Institute of Agricultural Economics Sofia, Bulgaria, Institute of Agricultural Eco-Bucharest. Romania. nomics and Timiryazev Academy, Russia. The programme entails a coherent series of conferences, summer schools, and training courses jointly organised with partners in Bulgaria, the Czech Republic, Germany, Hungary, Poland, Romania, Russia and Slovakia. The series of events offers unique training opportunities for junior researchers who want to join an international network.

Subjects of the Training Course

The course will introduce the participants to the present state of research on cooperation as a participatory institutional arrangement and co-operatives as a mode of economic and social organisation. Particular emphasis will be put on analytical and conceptual frameworks that serve as heuristics for cooperative studies and on institutional approaches which represent a foundation for co-operative theory.
